Outline your previous experience and involvement in Gymnastics.

I am a professional gymnast in the past, I was a successful gymnast for over 9 years and I have a certificate of the «Candidate for Master of Sport».

Currently I'm Level 2 British Gymnastics coach (the exam is still pending, but BG awarded it until then). As a director of gymnastics school I actively cooperate with London and International RG clubs.

I established good and friendly connections with various European Clubs, and I encourage our gymnasts to participate in various international competitions. Over the past year our gymnasts were competing in Hungary, Poland, Slovakia, Finland.

We also do summer camps for our gymnasts in England and abroad and invite coaches from Ukraine, Russia and Belorussia to participate in the coaching.

I have two High Law Degrees from Ukrainian and English Universities, I am a Master of Laws in International Business Law and graduated from London School of Economics and Political Science.
