Who can enter?

This competition is for:

Gender	All welcome (see specific event)			
	6 years plus, born <mark>2018</mark> or earlier			
Age	Gymnasts must be of age [to enter the appropriate category] in the <u>year</u> of the competition.			
	For example: A gymnast born in 2018 will be eligible to enter the age 6 category however they may still be 5 years old on the day of the competition.			
Ability	These competitions are aimed at gymnasts training a maximum of 1 – 6 hours per week (category dependant) within a competitive Gymnastics For All setting.			
Team Competition	For 2024 the team competition will be Novice and Intermediate levels only. Each club may enter one team at each level with a maximum of 6 gymnasts per team (4 top scores to count towards the team total). Gymnasts must be aged between 8 and 18 years old (in the year).			
ream competition	Individual clubs can select their team members by any method, no qualifier is necessary. Teams can be made up of all boys or all girls but cannot be mixed due to the different routines being performed.			
Club, County, Region	Open to all British Gymnastics clubs who are affiliated to East Midlands Gymnastics Association (EMGA). Anyone within the East Midlands region can be affiliated.			

General Entry Information:

In fairness to all gymnasts, the coach should decide at what level gymnasts compete.

Gymnasts must compete in the same level on all apparatus.

Gymnasts may only compete <u>one level in each calendar year</u> unless they are moving up a level between the four piece competition and the 2 piece competition in the autumn.

Gymnastics for All (GFA) rules are designed to be inclusive, gymnasts with additional needs may take part within a mainstream category or a disability specific category. If any gymnasts have specific additional needs/support, please make the Competition Organizer aware upon entry.







Gymnasts that have:

- Entered Artistic Floor and Vault competitions are not eligible to enter Regional GFA competitions
- Entered Gymnastics for All Floor and Vault competitions and won a medal must move up a level in the following year
- Entered Gymnastics for All Four Piece competitions and won a medal must move up a level in the following year
- Entered Artistic County or Regional Four Piece Competitions zinc or above or Regional/National Grades and / or Tumbling National 1 at or higher are not eligible to enter Regional GFA competitions
- Competed at Club Grade 6 and 5 can enter as long as they are only doing the hours of training limit and have not entered an artistic competition in the same calendar year
- Been a former Artistic Gymnasts wishing to compete at a lower level may do so, but must not have competed for one full calendar year, and must enter at the Advanced level or higher

Note: With all points, the discretion of the coach's professional judgement on the level which a gymnast should enter; and they should not advance the gymnast beyond their level or hold the gymnast back for the success of the club.

Apart from the above restrictions, you may enter any gymnasts at any level e.g. a gymnast could enter the Advanced although they have never entered a competition prior. Thus, keeping in mind the physical and psychological factors involved with entering a gymnast at a higher level as their first time.

Maximum training hours

To ensure a fair competition, we have set the following maximum training hours per week:

This applies to each individual gymnast and includes all training hours no matter discipline.








Structure and Levels

Payment method

As part of the British Gymnastics online entry system (GymNet), you will be able to pay for your entries.

Please ensure the correct amount is paid upon entry. Without payment, entry **will not** be submitted or counted.

Late entries

Entries received after the entry closure date may incur the following additional administration charge:

If you believe your entry will be late, please contact the Competition Organiser to discuss your situation. Each case is taken on individual basis.

Changing of a gymnast involved in the competition

Pre-event entry closure

If a gymnast is unable to attend the event for a specific reason (injury, illness etc.) then you can transfer (change) the gymnast so you maximise the opportunity for your club.

- Not submitted your entry yet? You can manually amend your entry list on GymNet
- Submitted (paid) for your entry? You will need to email the Competition Organizer to request a transfer in gymnast, as this must be done manually.

Post event entry closure

Contact the Competition Organiser to discuss your individual situation and the stage of event organisation. It may be too late to alter any preparation that has been completed.

If a transfer is accepted and must be done manually, the Competition Organiser will need the following details of both the old and new gymnasts:

- Full name
- Membership number
- Category Level and Age

Confirmation of entry

Upon entry and payment of entry; you will receive a confirmation email for your entry.

Confirmation of programme

After the entry closure date, the Competition Organiser will finalise the competition programme/running order and circulate this with all clubs involved.

If you haven't received an email of the competition programme five days prior to the competition start date, please contact the Competition Organiser.







Disability Gymnastics

Adaptations: Disability or Mainstream category?

When deciding with your gymnasts if they wish to enter a competition, you need to discuss if they wish to enter as into a mainstream category or a disability category.

To support gymnasts to integrate into mainstream gymnastics there can be certain adaptations allowed without effecting how the gymnasts are scored/judged. If you would like to discuss any possible adaptations prior to entering this event, please contact the Competition Organiser whereby you can discuss the most suitable option based on the needs of the individual

Gymnasts will be categorised into impairment groups dependant on the number of entries as you will see in the classification section below.

Entering: Mainstream category

Following the process set in the <u>Entry method and closure date</u> section, completing the 'Gymnasts details' tab.

Entering: Disability category

Following the process set in the <u>Entry method and closure date</u> section, completing the 'Gymnasts details – Disability Gymnasts' tab.

Disability Gymnasts: Classification of impairment

As part of your entry form you will be asked to select the most appropriate classification(s) for your disability. This will help the Competition Organiser to organise the most appropriate categories for the competition. The Competition Organiser will use a similar process to create the appropriate categories for this event:

Rewards

- All competing gymnasts will receive a participation ribbon or rosette
- Age groups will be bigger in 2024 however we will be awarding Apparatus places as well as All Around Overall places.
- Places 4th, 5th and 6th All Around and on each apparatus will receive a ribbon
- Places 3rd, 2nd and 1st All Around and on each apparatus will receive a medal
- All Around 1st place winner in each age group will also win a trophy.

Additional Competition details

Warm up

The programme will include a general warm up at the start of the competition and also on each apparatus. Timings will be included in the Competition information and sent with the Competition programme. Timings are subject to change at the competition organisers discretion.

Event day music requirements

Please ensure you bring a copy of your music on the day as a backup, ideally within the following formats:

- USB (for laptop)
- Fully charged portable device e.g. MP3 player/iPhone etc.

Please note that although very-low risk, any damages are your own responsibility and not the host or the Competition Organisers.

The host venue will also be abiding by the PPL/PRS licencing laws. Therefore, their maybe background music being played to help create a calming atmosphere. This will be the competition organiser/venue representatives' discretion.

Floor – Restarting

Where music has disturbed the gymnast due to a malfunction or incorrect use of, the music can be stopped/faded out and the gymnast come to safe stop. After which they can restart their routine from the beginning.

Although preferred not to for event time management (e.g. the more times it happens the later the event will finish), this is a General Gymnastics competition and the focus is the gymnasts.

Judging

There will be at least two judges on an apparatus panel, where possible to ensure the flow and fairness of the event is maintained. The Judging Convenor will appropriately place the judges in-line with their qualification and experience.

Appealing a judge's decision

Any appeals of a judge's Difficulty Value (DV) score decision need to be given to a Committee Member / Competition Organiser and must be submitted prior to the end of the competition. Appeals must be submitted by the gymnast' coach only.

This is a friendly, low-pressure, fun competition and we want to create a fair environment. We will strive to provide everyone with the best service possible.

Video evidence will not be accepted on any grounds. Constructive feedback can be passed to the committee via the appropriate Competition Organisers within one-week post event.

Additional requirements

If any anyone has any additional requirements to support their time during the event e.g., they have a disability that requires additional support or consideration by the Competition Organiser. Please add this into your competition entry.

If requirements are not upheld, then the Competition Organiser has the right to withdraw your (and possibly your clubs') right to step into the competition area.

If your club is unable to find a judge (or doesn't have one) please don't worry. Contact the British Gymnastics Competition Coordinator to discuss your options and how you can gain/train a judge.

Volunteers

Any person on the competition floor, including waiting and warm up areas, must be listed on the entry form and must be DBS checked.

Volunteers are not coaches' and therefore not allowed to 'coach'.

If your club is selected to provide volunteers for a competition they do not need to be DBS checked as long so they are not in contact with the gymnasts. An example of this would be if they are manning the door and taking entry fees.

Facilities on-site

Spectator area and disabled access

New College, Erewash Valley and Witham Hill sites have disability access. If you require any specific access, please contact the Competition Organiser.

New College, Amber Valley and Erewash Valley sites have plenty of seating for our events. Witham Hill currently has seating for approximately 120. Seating is made from plastic materials, if you require a softer seat please bring suitable padding.

Food and drink

Catering facilities can differ depending on the site and the time of the competition, please check with the competition organiser prior to the competition.

Toilet and changing facilities

All venues have baby changing facilities and plenty of toilets.

On-site entertainment

None of our venues have any on-site entertainment facilities apart from the sport of gymnastics. If you have small children, you may wish to bring something to keep them entertained.

We can't take responsibility for any losses or damages to personal property.







Car parking

All venues have plenty of free parking on and around the site. If car parks are full and you are parking on public roads please be careful not to block access to other local businesses.

First aid and welfare

The following provision will be available during this event:

- Trained First aider
- Trained Welfare Officer

It would be most helpful if the supporting coach from each club is First aid trained (or more) particularly to support their own gymnasts, however this isn't essential.

Etiquette

While competitions can become competitive, please ensure you support every gymnast, coach and parent/guardian involved. Everyone has been involved at some point and every competition/event is a celebration of those efforts.

It is important that the access to the 'Officials area' (judges, scoring, music etc.) is restricted to authorised personnel only.

The Competition Organiser has the right to withdraw any entry/entries where appropriate etiquette and professionalism isn't upheld before, during and after the event. This therefore could affect future attendance at events and become a welfare issue.

Photography

It is your responsibility as the coach in charge of your entered team/club to be aware, and have records, of anyone that can/can't have their photo/video taken for media purposes. If you have anyone that can't, please ensure the Competition Organiser is aware prior to the date of the event so they can inform the appropriate persons so that any photography/video of them is avoided. **This can be done via emailing the Competition Organiser upon entry**.

The following information is taken from the British Gymnastics policies and must be passed onto those who will be representing your club at this event, including spectators. At various points throughout the day the hosting club will also announce this information:

In the interests of child protection, photographs and video may only be taken during today's event in accordance with conditions set by British Gymnastics. Summaries of these conditions are on display and you can see a copy of the full conditions at **the reception desk**. Photos may only be taken for personal use. Unless specifically accredited to do so, you may not take photos for sale, other commercial use or for publication in printed or electronic form, such as on websites.

Some photos may be published by Clubs, but this may only be done in accordance with the British Gymnastics Child Protection Policy.







DE Photos may be on-site during Regional GFA events to help capture each gymnasts' special moments.

If you have any concerns about the identity or actions of any photographer or if you believe that any unsuitable photos are being taken, you should report your concerns to **Welfare Officer/Competition Organiser**. In the interests of child protection please do let us know of anything that may be damaging to the welfare of a child.

The use of flash or supplementary lighting is not permitted while gymnasts are warming up or competing. Please make sure that the flash is turned off on any device being used as your camera.

The **use of live streaming is not permitted** during any part of this event.

When 'posting' images on personal social media please ensure the following to reduce the risk of publication of the image (this isn't the full list but key from the policy):

- Personal details are kept to a minimum Use of their first name only etc.
- Suitable, sensible, and appropriate image taking/selection Avoid such skills as splits and sensitive areas on the body
- Blur anyone else out of the image Use technology to blur others out the image (if you can't, don't take/post the image)

If the Competition Organiser/Welfare Officer suspects inappropriate photography or filming, the Officer/Organiser should exercise their powers under the conditions to request the person to leave the venue and to surrender any film and/or delete any images relating to the event.

Complaints and grievances

If you have a complaint or grievance regarding any happenings about or at this event, please ensure you send in your details to the Chairman's or Competition Organiser's email within five working days of the event date.

If there is a problem on the day of the competition, the competition will go ahead as programmed, and the problem will be addressed later after the competition with the parties concerned.







The parties with the grievance will meet the committee to see if an amicable decision can be made for the good of all parties and Gymnastics for All Committee.

It will then go to a committee vote.

If no agreement can be made the Chairman will make the final and binding decision.

Health and safety

Overview

The health, safety and welfare of all participants (gymnasts, coaches and officials) is the primary consideration. All British Gymnastics policies and procedures will be rigorously applied with regards to health, welfare and safeguarding and protecting children.

The intention of the event is to create a friendly and no-stress/low-pressure environment for all those involved, while allowing gymnasts the opportunity to challenge themselves to do their best. Ensuring the safety of the gymnasts, no matter their age, is a priority in the event set up, programme design, and risk assessment, using the guidance set out by British Gymnastics in its Safe Coaching Practice document – https://www.british-gymnastics.org/documents/clubs-schools-and-leisure-centres/8851-h-s-guidance-safe-coaching-1/file

Risk assessments

Risk assessments have been carried out for this event but if you feel there is something/one that may require additional assessment please contact the Competition Organiser ASAP with specific details.

While risk assessments for the event have been completed, your club is responsible for specific risk assessments related to your club e.g. travelling to and from the event etc.

Welfare

As part of your risk assessments and preparation for the event, please consider the welfare of individual gymnasts, including such items:

- Clothing not being revealing/embarrassing for males, females, and transgender gymnasts/coaches/judges.
- Age of gymnasts when changing, socializing etc.

The British Gymnastics Health, Safety and Welfare policy has guidance on such areas and there are a few videos/courses which may help you also:

Allergies

As part of the safety for everyone, please ensure you pass on the message to all your coaches, gymnasts, judges, and parents/spectators that any food being brought to the event should be **nut free** and keep in mind any other potential allergies that could be affected by food being brought.

Emergencies

As part of event, everyone attending must adhere to the emergency procedures and follow the professional guidance of the Competition Organiser and members of staff from the venue. Below is a brief guide of the venue emergency procedures.

At all venues

Coaches must remain in charge of their gymnasts, leading them out the nearest fire exit and to the appropriate meeting point (see signage in venue).

Spectators will leave via the nearest emergency exits in an event of an emergency.

Judges are to support the coaches in leaving the venue with their gymnasts but to report to the head judge once at the appropriate meeting point.

At New College (specifically)

In the event of the emergency alarms sounding please evacuate via one of the following routes:

- Spectators Use the emergency exits at either side of the seating
- Gymnasts, coaching, and managers Use either of the three emergency exits in the main hall
- Café Follow the emergency exit signage to the South Entrance car park emergency exit route

Meeting point is in the South Entrance car park.

At Erewash Valley (specifically)

In the event of the emergency alarms sounding please evacuate via one of the following routes:

These will be highlighted on the day during a safety briefing

The meeting point is within the car park (side of building)

Coaches are to ensure all their gymnasts are kept together until registered and then handed back to their responsible adult.







At Witham Hill (specifically)

In the event of the emergency alarms sounding:

Spectators on the balcony evacuate to the left and down the fire escape

Spectator in the gym evacuate via the double doors entrance

Gymnasts evacuate through the fire door leading directly to the car park

The meeting point is the car park at the side of building

Coaches are to ensure all their gymnasts are kept together until registered and then handed back to their responsible adult.
